**Effective March 18, 2020, the Federal Aviation Administration Civil Aircraft Registry (FAA Registry) will no longer have a filing window open to accept documents for immediate filing. The FAA Registry has established a protocol for the filing of documents, and will be processing documents on a non-priority and a priority basis. Insured Aircraft Title Service will not be able to get an immediate filing time for the documents that are filed. Insured Aircraft Title Service will have to wait until filed documents have been indexed, scanned and available for viewing online to be able to determine the actual filing time of documents. It is unclear at this time how long this will take. This will affect the ability of Insured Aircraft Title Service to search the FAA Registry's indices of filings on an up-to-date basis.**
